# With cooperation we create a safety net for a child

The year 2019 showed us the scope and significance of our cooperation network once again. We at Interpedia are just a small thread in the net that will carry a child for hopefully a long time in his or her life.

A wide range of people affect the decisions concerning an adoptive child's life at a very early stage. There are authorities, healthcare professionals, caretakers, other employees of children's homes or foster families and possibly therapists. At some point they are joined by adoption authorities of the country of birth and adoption organisations' staff, and us from Interpedia. With this international network we cooperate confidentially for the best interest of the child.

Our adoption work here at Interpedia is supported by many parties in both Finland and Europe. There are authorities and financiers who supervise our work; colleagues in Finland and in other receiving countries, with whom we share knowledge and know-how; there are consulting physicians and social workers from adoption counselling who we work closely with during the process.

Finally, the most important network gathers around the child – a permanent family of his or her own and the family's entire inner circle.

Through post adoption service, we are sometimes in adopted children's lives even years later. Biological relatives may also enter their lives at some point, as an additional thread in this wide network of relationships.

In development cooperation, our partners are an essential link in our work for promoting good childhood. The most important relationships in a child's life are with his family, relatives and friends. We can, together with our partners, be there to support their lives towards a better future and give them new alternatives, often through education and/or rehabilitation.

We often work with children who are in the most vulnerable position in society. Changing their lives will not only have an impact on their life but benefit the entire community and we can play a vital part in this on the grassroots level.

All our donors, sponsors and funders bring their own significant thread into this work of ours as a part of a child's safety net.

A big thank you for the past year to all Interpedia's customers, monthly donors, sponsors, adoption and development cooperation partners, financing organisations, cooperation networks and to the Board and staff of Interpedia.

Special thanks to all the children! We are proud to be a small part in the vast networks of your life.

# International adoption **work in 2019**

In 2019, there were 52 of boys and girls were 28 and 24, respectively. children adopted to Finland through Interpedia (2018: 28). Interpedia's share of all the children adopted internationally through adoption agencies in Finland was 78 % (2018: 54 %). # Adoption work is cooperation

doption work has become increasingly individually oriented and tailored, and it requires extensive cooperation both in the contact countries and in Finland.

"In our work we need to be constantly present in the moment. We need to participate intensivelγ in the lives of the children as well as every applicant family because big things in their individual lives are in the making. At the same time, we need look into the future. We have to take part in the discussion about the future of international adoptions and take responsibility for the entirety and continuity. We need to see, simultaneously, near and far."

In the contact countries there is a need especially for applicants who are capable of meeting the needs of a child with special needs. In our adoption service the staff members meet with applicants regularly during the waiting period to get acquainted with their situation as well as possible. Close collaboration with the consulting physicians and the social workers of the adoption counselling is also essential. It is in the best interest of the adoptive child and the sending country that our applicant families are well prepared for the adoption.

In 2019, we held 43 info sessions on international adoption and the contact countries, including some sessions in Swedish or English. The sessions were attended by around 400 people in total.

Together with other actors in the adoption field, Interpedia organised an Adoption Day and a seminar called The Growth Towards Adoptive Parenting, which included lectures by various experts. The traditional training session for adopted children's grandparents and other close ones was again very popular and the participants regarded it as very useful.

"Suddenly I realised that they were asking for me, too. They were interested in my stories and they came fishing and mushroom picking with me. They haven't stayed overnight yet unlike my grandchildren who have lived in their families since their birth. But otherwise I don't see a difference in the quality of grandparenting an adoptive or a biological grandchild. All my grandchildren are very dear, all too active, lovely personalities."

The Finnish Adoption Board operates under the control of the National Supervisory Authority for Welfare and Health (Valvira), and Interpedia is a member of the Board's plenary session. Interpedia was represented in the session by Ms Salla Hari, Director for Adoption Program, with Executive Director Anja Ojuva as deputy member. Ms Ojuva was also a member of the Consultative Committee for Preventive Child Welfare of the Central Union for Child Welfare in Finland (LSKL). Social Worker Sanna Alanko represented Interpedia in the Steering Group for Adoption Counsellor Activities of the organisation All Our Children.

The three adoption service providers operating in Finland (Interpedia, Save the Children, and the City of Helsinki) continued to engage in close collaboration.

# International cooperation of the adoption service

uring the year 2019, staff members of Interpedia's adoption service visited several contact countries, carried out negotiations with partners and met with authorities responsible for adoption issues. Visits to Finland by partners in the contact countries are also important and reinforce mutual trust and cooperation.

Our adoption service collaborates closely with both Finnish embassies in contact countries and their embassies in Finland. The embassies are visited regularly.

"Interpedia's senior adoption coordinators Ms Marika Elmeranta and Ms Eija Kiiskinen were on a business trip in Thailand last week. They headed first to the northern parts of the country, where they visited Vienping Children's Home. In northeastern Thailand they visited Udon Thani home for Girls in Udon Thani and Khan Thong Children's Home in Khon Kaen. In the end Ms Elmeranta and Ms Kiiskinen visited three children's home in Bangkok area: Pakkred Babies Home, Phya Thai Babies Home and Rangsit Babies Home, where they had good discussions with the psycholo*aist and the social workers.*

# Post-adoption service at Interpedia

The need for post-adoption service increased further. Together with other Finnish adoption service providers, Interpedia received funding from the appropriation granted by the government to Valvira (National Supervisory Authority for Welfare and Health) for this purpose. Thanks to this support, we can expand the range of our post-adoption service activities and develop new forms of service.


Post-adoption service can be helpful in many kinds of life situations. The service can, for example, provide information about the adoption documents in meetings at the office, request more information on the background from the adoptee's country of birth or support in organising a root-seeking trip. Both adoptees and their families are welcome in Interpedia's post-adoption service.

Post-adoption service also responds to queries coming from the birth country. In these cases Interpedia contacts the adoptee and supports him or her in receiving the information. We also inform adoptive families of any changes in the practices of the sending countries, and ensure compliance with the statutory obligation to maintain archives.

In 2019, we provided information about post-adoption service in six info meetings during country meetings for adoptive families. In addition, we held an info session on post-adoption service for adoptees in cooperation with other actors in the adoption field.

# #Adoptionilo (#AdoptionJoy) campaign

Interpedia, together with other actors in the field of adoption, organised the third #Adoptionilo/#Adoptionsglädje (Adoption Joy) campaign in connection with the Adoptees' Day in March. The purpose of the campaign was to demonstrate that adoptive families and adoptees mostly lead a perfectly normal daily life. During the week, adoption organisations, adoptive families and adoptees shared stories of their everyday life in social media. Like the year before, the campaign was a success, and a decision was made to continue the campaign in 2020.

"Before the first pick-up trip, we were told that everything goes well if everybody comes home alive. This is a good piece of advice. The trip itself and life at the hotel is not the same as everyday life. When the normal everyday routines start, life will get a lot easier. At least our children need routines to make life easier. The more closely we follow the routines, the better the day goes.

Trust your own intuition. It is also perfectly normal and acceptable if you are having mixed feelings. The love for the child will grow to incredible heights when the attachment develops and strengthens."

# Development cooperation in 2019

In 2019, Interpedia supported 15 projects and programmes improving the status of children and promoting child rights in seven countries, with 14 cooperation NGOs. One project with funding provided by the Ministry for Foreign Affairs for development cooperation projects continued in Nepal. Two new projects started, one in Nepal and one in Ethiopia.

Inclusive and Accountable Schools – developing the school environment in Nepal is a joint project run by Loo Niva Child Concern Group, Patan Community Based Rehabilitation and Interpedia, aimed at promoting opportunities for access to school and continued school attendance of children living on the margins of society in Southern Lalitpur. The project is particularly targeted at children with disabilities, children without a caste, and girls.



Children with disabilities also have the right to education. In Nepal, in South-Lalitpur region, the work to ensure that the children with disabilities have access to education starts with finding the children and by mapping out their situation and needs. Sometimes the obstacles the NGOs face are physical, sometimes work needs to be done to change people's attitudes. (Interpedia on Instagram 14 October 2019)

Strengthening Education Policies and Ensuring the Right to Education in Nepal is a joint project run by Loo Niva Child Concern Group and Interpedia. The NGOs have previously cooperated in the Dadeldhura region, in the Far-West of Nepal. Dadeldhura is one of the least developed areas in Nepal, where vulnerable children such as girls, ethnic minorities and Dalits face discrimination and have lower access to education. The project enables quality education in the new provincial structure of Nepal and ensures better educational policies. In addition, the project will improve learning achievements and reduce dropouts in two municipalities, reaching over 4000 school-going children in 32 schools, their families and 60 teachers.



Creating a safe and equitable living and learning environment for children with disabilities in Ethiopia

project is conducted in Debre Zeit and Dukem towns in cooperation with Berhan Lehetsanat. In Ethiopia disability is still a source of social and economic exclusion. The direct beneficiaries are over 200 children with disabilities and their parents, 60 children with disabilities in skills training as well as schools, government representatives and communities. The project enhances the overall wellbeing and integration of children with disabilities and their families

Monitoring trips were conducted twice to Nepal and Ethiopia and once to South-Africa during 2019. During these trips we evaluated the progress of the development cooperation projects, met partners from co-operating countries and visited Finnish Embassies.

At the end of 2019, Interpedia had one volunteer working at Loo Niva in Nepal. We also started our renewed School Sponsorship program in cooperation with Loo Niva in the Far-West region of Nepal.



With the donations by Interpedia's 936 sponsors and monthly donors, we implemented 12 programmes in seven different countries in 2019.

The programmes focused on supporting the children's opportunity to education. In addition, some programmes included training for children, parents and the whole community on issues such as disability and the rights of the children. Small business and various income generating activities were also supported. Some programmes included therapy and social services provided for the families and organized various free-time activities and child care services. Some programmes supported activities of, for example, a children's home.

Co-operation with the NGO Promoting Human Rights and Education in Bangladesh (PHREB) ended during 2019.

We arranged school visits on **global education** in the Swedish-speaking schools in Pohjanmaa and a Nepal theme day in co-operation with the Arabia school in Helsinki.

# EDUCATION AND REHABILITATION FOR DISABLED CHILDREN Berhan Lehetsanat, Debre Zeit

Berhan Lehetsanat aims at improving the well-being and education opportunities of disabled children in the project area. The organisation also implements educational work in the communities about, for example, the true causes of disability and how to prevent them.

### DAY CARE CENTRES AND EARLY EDUCATION FOR THE POOREST CHILDREN

### Maedot, Addis Abebe

Maedot does impressive work among the children of destitute families in Addis Ababa and the surrounding countryside. Together with Maedot, we have established a total of three day care centres in the poverty-stricken area of Addis Ababa, Woliso and Dilela.



In Interpedia's partner NGO Maedot's day care centre in Dilela, 23 children can spend their days in a safe environment while their mothers are working. At the centre these children of single parents get a free breakfast and lunch, prepared by a local women's group. The renovation of the day care centre will soon be finished, which enables the enrolment of new children. The bigger number of children requires more teachers. ### Loo Niva Child Concern Group Nepal

Loo Niva supports the education of children from destitute families in Lalitpur near the capital, Kathmandu, and in Dadeldhura in the Far West. Children's opportunities for participation are improved by supporting the child clubs in schools. The status of children is improved by supporting their school-going and by developing the quality of basic education and school environment. One objective is also to improve the administration of schools in Nepal.



Loo Niva's social mobilizers have a lot of work to do during the next four years. Dadeldhura is one of the least developed areas in Nepal, where vulnerable groups such as girls, ethnic minorities and Dalits face discrimination and have lower access to education. In the joint project of Interpedia and Loo Niva basic education is developed by:

- ducating children, teachers, parents and local officials on the child's right to education
- strengthening children's participation through child clubs
- establishing local action groups to promote goals of quality education
- promoting good educational practices
- promoting peaceful education and avoiding misuse of schools as an instrument of politics





# Whose voice?

## Perspectives on Ethical Communications in **Development Issues**

During the first half of 2019, Interpedia continued the project Whose voice? Perspectives on Ethical Communications in Development Issues, as part of the Frame, Voice, Report programme funded by the EU and managed by Fingo.

Our goal was to highlight how southern civil society has solved development problems and achieved changes, using the work done to reduce child labour in Nepal as an example. The project also seeked new perspectives on the portrayal of extremely vulnerable children in communications in an ethical manner which respects their dignity.

In spring 2019, we shared information about the work done in Nepal to reduce child labour in our communications campaign and by publishing a mini documentary "Dreaming of Nepal Without Child Labour".

At the end of March 2019, we organised a Seminar on Ethical Communications and Journalism at the University of Tampere. In the seminar we discussed questions like: Is there a difference in privacy policy when reporting about children of poor countries? What kind of images is the media creating about developing countries? How to communicate ethically?

At the end of the project we published a checklist on ethical communications in Interpedia's blog and global education material on the themes of the project for secondary schools and high schools.

Whose voice? Dreaming of Nepal without child labour, part 2: Shanti Adhikari – long career in the field of women's and children's rights

The story of our partner organisation CWISH is, at the same time, the story of the progress of child rights in Nepal. Shanti Adhikari, the founder of the organisation, talks about the development of CWISH and the work that has been done in Nepal to defend the rights of child labourers in our blog: interpedia.fi/blog\_post.

The list of the measures is impressive: The organisation has, for example, searched for child domestic workers from households, educated them, returned them to their own families, spread information on child rights, trained teachers, started a programme against sexual exploitation, sued employers, started a widely recognised green flag movement (indicates a child labour free zone/place), promoted employment of adult domestic workers and supported livelihood of poor families.



### **ADOPTION COMMUNICATIONS**

In 2019, adoption applicants were sent eight newsletters, two leaflets about contact countries, two letters from the Executive Director and other brief e-mail newsletters. All the most important news were sent in both Finnish and Swedish.

During the year, we expanded especially the English language adoption website and published a brochure about our adoption service in Finnish, Swedish and English.

### DEVELOPMENT COOPERATION COMMUNICATIONS

During the year, sponsors were sent two general newslet- in Finnish, Swedish and English on our website, and the ters on development cooperation, programme highlights and greetings from the sponsored children. The sponsors also received our wall calendar 2020. Subscribers to Interpedia's electronic newsletter received five letters in Finnish and four in Swedish during the year.

Information about the results of development cooperation was shared in social media during monitoring trips. Our development cooperation, sponsor programmes and global education were also presented in the Educa Fair, World Village Festival and during school visits.

### MEMBER COMMUNICATIONS

In 2019, the members of Interpedia were sent two newsletters and the 2020 wall calendar with the theme Siblings.

The 2018 Annual Report was published in summer 2019 English translation also as a printed publication. During the year, we also published a general brochure about Interpedia in three languages.

# **Finance**

In 2019, Interpedia's adoption service activities were financed through adoption service fees and targeted funding for adoption service provision granted by the Funding Centre for Social Welfare and Health Organisations (STEA) (EUR 232,100). Post-adoption service received funding from the appropriation granted by the government to Valvira (National Supervisory Authority for Welfare and Health) for this purpose.

Development cooperation activities are financed through private sponsors and monthly donors, other donations, project funding from Fingo (Frame, Voice, Report) and project funding provided by the Ministry for Foreign Affairs for financial support for development cooperation projects by civil society organizations.

In 2019, the Finnish Ministry for Foreign Affairs supported Interpedia's projects by EUR 336,000. The fundraising from sponsorship activities amounted to EUR 242,778, and

other donations received totalled EUR 14,200.

The funding for adoption activities provided by STEA and the funding for development projects by the Ministry for Foreign Affairs are significant for the organisation's financial operation.

Interpedia's post-adoption service also received funding from the Gesellius Foundation and from William Thuring Foundation to visit country meetings for adoptive families. The Gesellius Foundation also supported our translation work from Finnish to Swedish. In addition, Inter-

pedia received funding from Brita Maria Renlunds Minne Foundation for global education work at Swedish-speaking schools. A warm thank you to the Foundations for their valuable support to our bilingual work, post-adoption service and global education.
